

# Temporary Stay Visa for Study/Student Visa (Index C316)

## Activities

This type of visa is granted to foreign nationals who intend to study in an Indonesian education institution. Holders of this visa are not allowed to work in Indonesia.

DETAILS	DESCRIPTION
Study in Indonesia	A student intends to enroll at an educational institution in Indonesia.

### Duration of Stay

You are allowed to stay in Indonesia for six months or 180 days, one year, or two years depending on your application.

Stay permit for this type of visa is extendable.

## Procedure and Requirements

You or your sponsor can apply for a Temporary Stay Visa through the [Online Visa Approval application](#), and submit the below documents:

1. Letter of sponsorship from a sponsor who is an Indonesian citizen or the institution/organization where the foreign national participates in educational activities;
2. A valid nationality passport.
  - A minimum of 12 (twelve) months for those who will stay in Indonesia for a maximum of 6 (six) months.
  - A minimum of 18 (eighteen) months for those who will stay in Indonesia for a maximum of 1 (one) year.
  - A minimum of 30 (thirty) months for those who will stay in Indonesia for a maximum of 2 (two) years.
3. Proof of funds of at least US\$2000 (two thousand US dollars) or equivalent to support the cost of living of foreign nationals and/or their family in Indonesia.
4. 2 (two) color photographs with a size of 4 cm x 6 cm (four centimeters by six centimeters) with a white background.

5. Letter of recommendation for study issued by the government institution coordinating education or religious affairs.
6. Suppose the sponsor is an institution or organization where the foreign national study. In that case, the letter of recommendation for study can be substituted with a letter of statement from the institution or organization declaring that the applicant is admitted to enroll.

## Additional Requirements

Proof of having received the full dose of COVID-19 vaccine.

## Visa Submitting and Processing

Sponsors or foreign nationals can apply for a visa on the official website of the Directorate General of Immigration at [www.imigrasi.go.id](http://www.imigrasi.go.id) or directly on the [Online Visa Approval application](#).

1. review of the submitted documents;
2. payment of immigration fees by applicants;
3. *profiling* and verification
4. visa approval
5. visa issuance

## Processing Time

The processing time for a visitor visa is 4 (four) working days after the applicant completes the immigration fee payment. Sponsors or applicants can check their visas in the Online Visa Approval application account and email.

## Fees

- Temporary Stay Visa: US \$150 per application
- Temporary Stay Visa approval: Rp200,000 per application
- Temporary Stay Permit for 6 months/180 days: Rp1,000,000 per application
- Temporary Stay Permit for 1 year: Rp1,500,000 per application
- Temporary Stay Permit for 2 years: Rp2,000,000 per application
